## SUMMER ATHLETIC PARTICIPATION TICKET

This TICKET must be signed by the student and parent/guardian and presented to the supervising coach upon arrival to the school facilities each day. Once the coach receives this TICKET, the coach will then complete the MHSAA COVID-19 Monitoring Form for each student. AN UPDATED TICKET MUST BE COMPLETED FOR EACH DAY THE STUDENT PLANS TO PARTICIPATE!

Please note that locker rooms and indoor facilities will not be open. Students should arrive at outdoor workouts in proper gear and immediately return home to shower after the end of the workout. Students should bring their own water bottles and are not to share with anyone. It is recommended that students wear cloth face masks while on school property and always practice good hygiene. THERE MUST BE A MINIMUM DISTANCE OF SIX FEET BETWEEN ALL INDIVIDUALS WHILE ON SCHOOL PROPERTY AND DURING WORKOUTS!
